11 Million Points Competition **Conditions of Entry**

A. General

1. Information on how to enter this Promotion, mechanics of entry and prizes form part of these Conditions of Entry. Entry into this Promotion is deemed acceptance of these Conditions of Entry by each Entrant.
2. Entry is open to Australian residents who are Velocity Frequent Flyer members and 18 years of age or older (**Entrants**). The Promoter is Velocity Frequent Flyer Pty Ltd (ACN 601 408 824) of registered address 56 Edmondstone Road, Bowen Hills, Queensland 4006.
3. The directors, officers, management and employees (and their immediate families) of the Promoter and its related bodies corporate are not eligible to enter this promotion.
4. The Promotion commences at 00:01 AEST on 16 July 2019 and ends at 23:59 AEST on 30 September 2019 (**Promotion Period**).

B. Entry

5. Entrants will automatically receive one (1) entry into the Promotion when they: (1) download the Velocity Frequent Flyer app (2) log in to the Velocity Frequent Flyer app during the Promotion Period using a Velocity membership number, which must be linked to a Velocity Frequent Flyer account which contains either a valid contact number or email address and (3) must have the Velocity Frequent Flyer app installed at the end of the promotion period. Entrants will not be eligible for the Promotion if they have downloaded the Velocity Frequent Flyer app prior to 16 July 2019. There is a limit of one entry per Entrant for the duration of the Promotion Period.
6. Entries will be deemed accepted at the time of receipt by the Promoter and not at the time of transmission. Entries received will be considered final by the Promoter. Illegible, incomprehensible and incomplete entries will be deemed invalid. C. Drawing winners

10. The Winners (a **Winner**) may be announced on the Promoter's website after 12:00pm AEST on 15 October 2019. The Winners will be notified after 12:00pm AEST on 10 October 2019 directly by phone or email where further contact information and details may be requested including, but not limited to, full name, phone number, email address and residential address.
11. If the prize is not claimed within 90 days of publication, a redraw will be conducted. If required, the redraw will be conducted on 13 January 2020 at 12:00pm AEST at Anisimoff Legal, Suite 5, Erina Plaza, 210 Central Coast Highway, Erina, NSW 2250.

40. Nothing in these terms and conditions limits, excludes or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the *Competition and Consumer Act 2010* (Cth), as well as any other implied warranties under the *ASIC Act 2001* (Cth) in Australia, or similar consumer protection laws in the State and Territories of Australia (**Non-Excludable Guarantees**). The Promoter, its associated agencies and companies (and their respective officers, employees and agents) exclude all liability (including negligence) except for any liability that cannot be excluded by law, including the Non-Excludable Guarantees, for any direct, indirect or consequential injury, loss and/or damage arising in any way in connection with this Promotion or any prize/s.
